PROPOSED NEW HANGAR AND GENERAL AVIATION APRON (GA 2) FOR AWAN INSPIRASI SDN BHD AT MIRI AIRPORT, MIRI, SARAWAK, MALAYSIA

1. PURPOSE

1.1 This Aeronautical Information Circular serves as Notice of Intent regarding the scope of works pertaining to the proposed new hangar and general aviation apron at Miri Airport. This AIC will be followed by a number of AIP Supplements that will provide details of the new connecting taxiway works, a new general aviation parking apron for 4 helicopter stands and a new general aviation hangar.

2. SCOPE OF WORKS

- 2.1 The scope of works prescribed for the above projects are as follows:-
 - 1. New 2 Storey Hangar cum Office Block for Awan Inspirasi Sdn Bhd., an aviation service provider company. The Hangar will be capable of accommodating up to 4 Sikorsky S92.
 - 2. New Connecting Taxiway, 15m wide for helicopter ground taxiing purposes situated between the Old General Aviation Apron and the New General Aviation Apron.
 - 3. New General Aviation Apron (GA 2) capable of accommodating 4 Sikorsky S92. The Existing General Aviation Apron will be renamed as GA 1 upon the completion of the Works.
 - 4. Infrastructure facilities including access road, car parks and utility services for the New Hangar area.

Appendix A and Appendix B attached show the locality and site layout plans.

3. WORK PROGRAMME

3.1 The Commencement & Completion dates for the above works shall be notified in the NOTAM and AIP supplement.


4. IMPLEMENTATION


